I have read through the entirety of your passage while keeping an eye out for facts that need verification, statements raising legal concerns, and information that reduces audience inclusivity. I began by an initial read through to develop a strong understanding of your product, values, and message. Then, I went back

through and noted anything that seemed to need clarification or conformation. After completing this process, I have left several comments regarding possible concerns.

To begin, I strongly advise that you include sources with your claims. This will help ensure that these claims are accurate and honest. The only claim that was attached to a source was the testimony of Bliss, who is the founder of the company. The inclusion of sources and evidence adds to the credibility of the fact, and ultimately your company. Also, including specific facts (i.e specific immune disorders that went away) further builds evidence that your product is effective in healing processes.

Next, I advise caution in making major claims against companies. Major claims and generalizations, especially without evidence and or sources, raises major concerns for legal prosecution. The claims about pharmaceutical corporations strongly stands out to me. As a copy editor, I cannot identify specific legal violations, but can only advise that you err on the side of caution when making claims and accusations.

Lastly, I suggest that you include definitions of jargon throughout to expand audience inclusivity. I noted multiple concepts and terminology that are specific to this industry and included without definition. Remember that you are a professional in this field, but odds are the majority of your audience is not. The inclusion of definitions will help the audience better understand your product, company, and goals. It will also make people feel more connected to and confident in your product if they are able to better understand it.
